Notice that there is a place that MUST have a signature. Please be sure to sign the following lines:

- Medical release and transportation
- Agreement of program policies
- Water permission slip

Please make sure the staff knows of any medical problems/limitations your child may have.

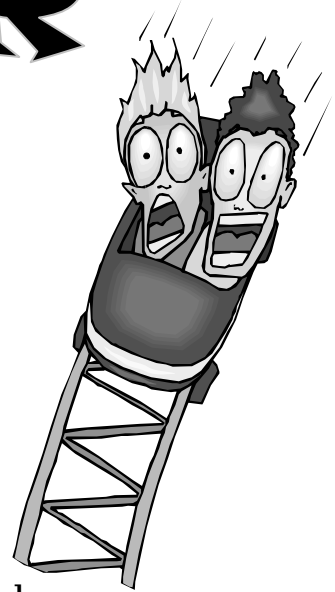

Attention Parents

- The summer hours are from 7:30am-6:00pm daily. If you feel you will be arriving after 6pm please make other arrangements for your child(ren) to be picked up by 6pm otherwise there be a **\$1.00 a minute late fee per child** and will be paid directly to the staff closing that evening. Your child(ren) can not return until the payment has been made. The time is according to the staff members' clock or the church clock.
- There are **NO** refunds or credits on days missed or field trips unattended. Be aware that if you pay in advance for your child(ren) to attend any field trip or pay for the daily fee and they do not attend for **ANY** reason there will be no refund or credit towards a future date. Your payment will be considered a donation to the Boy's and Girl's Club and will be used to further our programs.
- In the event of a behavioral problem, your child(ren) can be asked to stay behind from a field trip, or in an extreme situation, we will call the parents and have you pick your child(ren) up. And your money for that day and/or field trip will not be refunded.
- If not in advance, parents **MUST** pay for daily fee or field trips the morning of, when you drop off your child(ren). Field trips **MUST** be paid for, the morning of, going on the field trip. There will be **NO** paying the fee's later. If you do not have the money then the child(ren) stay back from the field trip.
- You **MUST** provide a sack lunch for your child(ren) every day. Nothing that has to be kept cold or nothing that needs to be heated up. We will not have access to a refrigerator or micro-wave. Even if your child(ren) are going on the field trip and you have given them money to buy something. You will still need to provide them with a lunch due to maybe the concession won't be open. It has happened before. **ABSOLUTELY NO** sodas of **ANY** kind!!! Water, water, and more water. Gatorade, powerade, and or vitamin water can be brought too.
